We submit these guidelines to assist you in qualifying, submitting, and binding Non-Fleet Long-haul Trucking business with RLI Transportation. They are subject to change without notice.

## **Agents / Brokers:**

- RLI Transportation will accept new submissions for consideration, <u>from approved retail Agents /</u>
  Brokers
- Agents / Brokers must be appointed and licensed with RLI, in their respective state, <u>prior</u> to binding their first submission

## **Eligible Trucking For-Hire Operations – TL & LTL Carriers:**

- Dry Van
- Refrigerated
- Auto Haulers/Boat Haulers (No Cargo coverage available)
- Flatbed
- Intermodal (except: South Florida, NY, NJ, Chicago, Houston, Los Angeles)
- Hotshot Haulers

## **Ineligible Mileage Operations:**

Operations running more than 125,000 miles per unit

#### Size:

1-5 Power Units only

## **Financial Requirements:**

- · Acceptable commercial credit score on DNBI or Experian or
- Acceptable personal credit score for unincorporated sole proprietor

## RLI Transportation writes non-fleet operations domiciled in all states, except:

- Massachusetts
- Hawaii
- Alaska
- Louisiana
- New York & Metro Area
- New Jersey
- Florida
- Virginia
- We do not accept any size intermodal in and around Chicago, IL

## Mileage Requirement

Vehicles must average below 125,000 miles per year

# **Lines of Coverages Offered:**

- Auto Liability, including Hired and Non-owned options
- General Liability (CGL)
- Physical Damage (\$1,000, \$2,500, \$5,000 deductible)
- Cargo up to \$100,000 limit (\$1,000, \$2,500 deductible)

# Years in Business:

Two (2) years minimum

## **Application Requirements:**

- RLI Non-Fleet Application must be filled out in its entirety. Our Quick Quote Submission System and applications can be found at: www.rlitransportation.com. MVRs are required for each driver.
- Account must have a DOT SAFER Safety Rating of "Satisfactory"

## **Driver Qualifications and Motor Vehicle Reports:**

- MVRs must be run for all drivers and be no more than 60 days old
- MVR Guidelines:
  - 1. Minimum age of 23
  - 2. Minimum of 2 years CDL-A driving experience
  - 3. Maximum of 3 moving violations in last three years, or 2 moving violations and 1 minor accident
  - 4. No DUI's or Felony Driving Convictions within the last 10 years
  - 5. No major moving violations (e.g. non-felony reckless driving) within the last 5 years

#### Pricing:

- Premiums are developed based upon mileage by state
- · Pricing is on a "per unit" basis

## **Quotes:**

- Quotes will be processed, once a complete submission is received
- We will make every effort to quote within one (1) business day of receiving a complete submission, but no earlier than 30 days prior to the effective date
